Matching Bonus



First Matching 2:1 or 1:2 = 500.00 and after Matching 1:1 = 500.00

Daily Capping, = 20,000.00

Matching Bonus = 500.00

Monthly Capping, = 6,00,000.00



Level Sponsor Bonus

You earn income from two things :

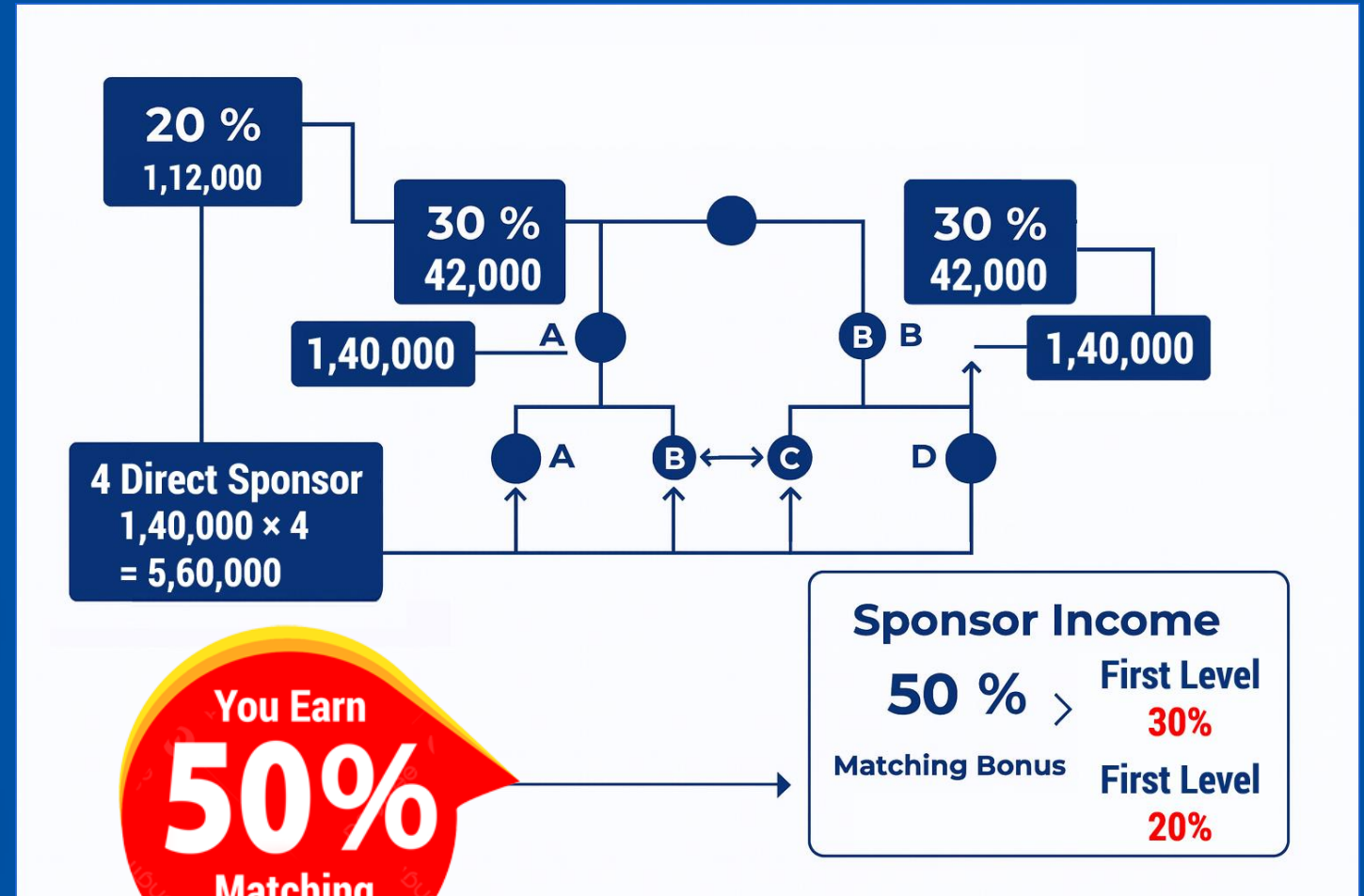
Direct Sponsor Bonus

You get a bonus for every person you personally sponsor.

So your income = Direct Bonus + Matching Bonus

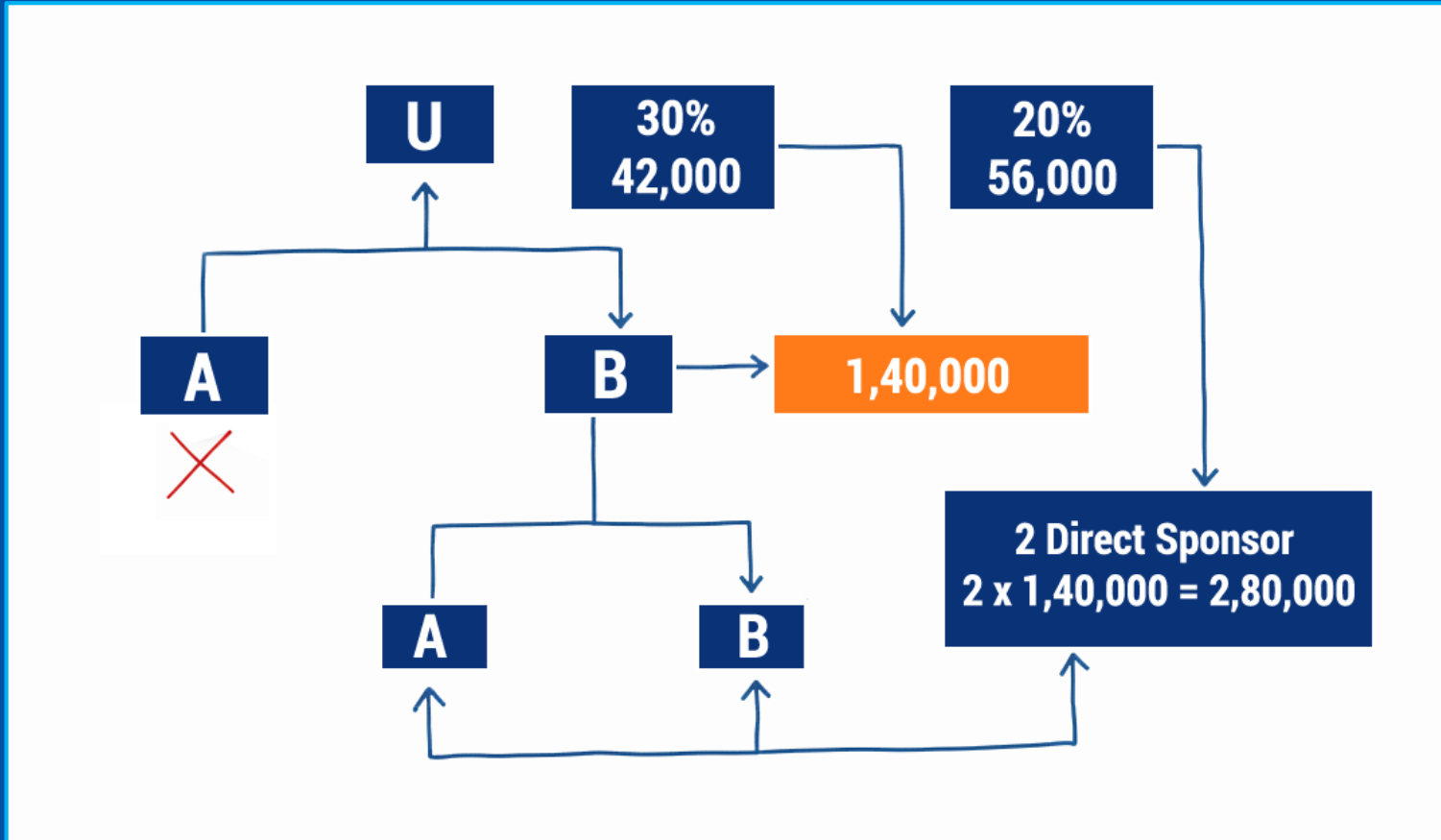
Your total earnings come from:

Matching Bonus
30% from A & B, 20% from C & D





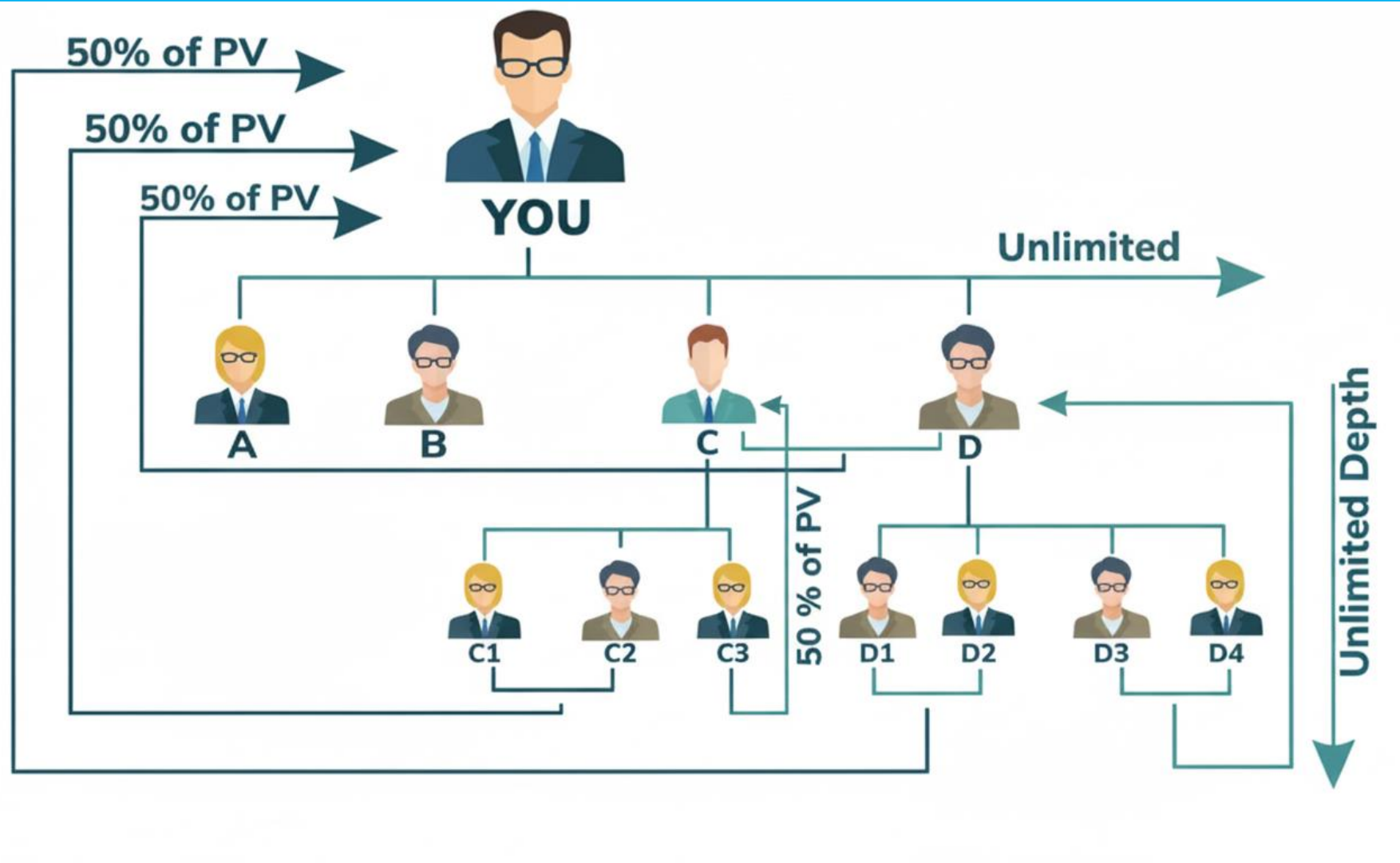
Single Leg Sponsor Bonus



- You earn a commission from direct referrals (30% of 42,000 and 20% of 56,000)
- Since you have 2 active directs, the system places their teams into a single-leg structure, generating continuous income from: Their team volume (1,40,000 each)
- A (top-left_red) is marked with X, meaning no income contribution.

Retail Profit



As a MySamarth Distributor, you save this amount as the Difference Between MRP & DP Price.



**MRP - DP (Distributor Price)
= Retail Profit**

3600 – 3000 = Rs. 600

10% To 40% Retail Profit



Self Repurchases Bonus



1300 DP - 10% = 130 Rs

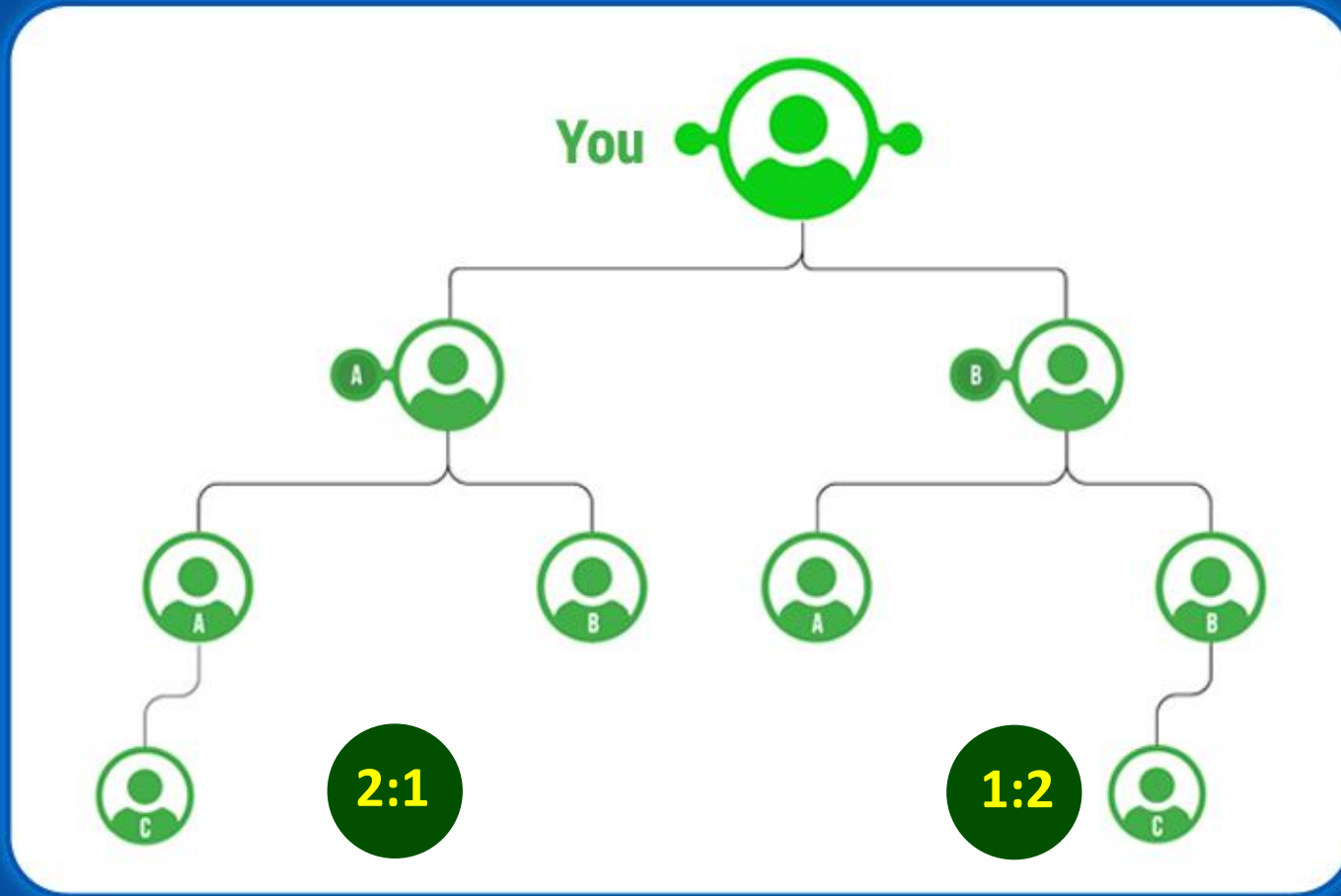

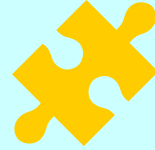

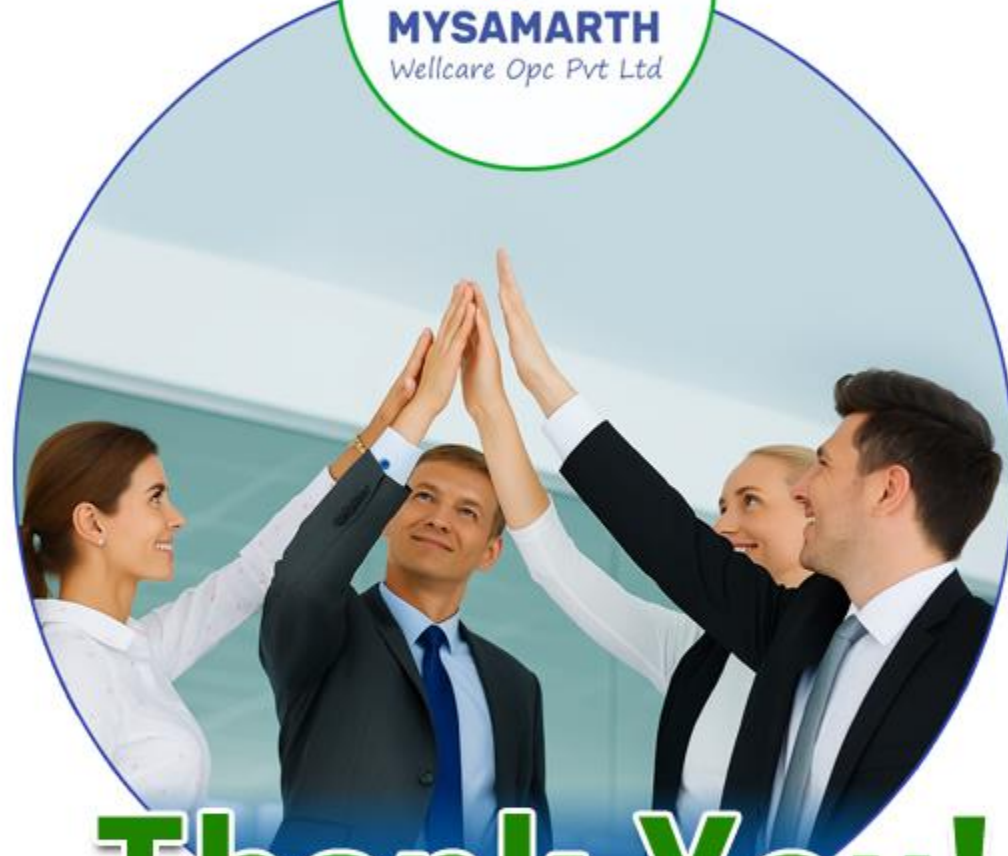
